

# STATUTE OF BONUS SPINS (FREE SPINS)

Valid for all free-spin promotional activities in the Gameworldbet online casino.

## A) Introductory Provisions

1. This statute regulates the conditions for granting, activating, using, and limiting bonus spins (“Free Spins”) provided to players in the online casino (hereinafter the “Casino”).
2. Free Spins are a promotional form of bonus that allow the player to receive free spins on designated slot machines without using their own financial resources.
3. The organizer of this activity is GameWorld s. r. o., Korzo Bélu Bartóka 2387/24, 929 01 Dunajská Streda, Company ID: 46 465 472 (hereinafter also the “Organizer”).

## B) Conditions of Participation

The bonus may be used by any person:

1. who has reached the age of 18 and meets the conditions laid down by Act No. 30/2019 Coll. on Gambling (hereinafter the “Act”), and
2. who, during the duration of this activity, has an established and verified player account (personal betting account) at [www.gameworldbet.sk](http://www.gameworldbet.sk) (hereinafter the “Player”).

## C) Definitions

**Promotional Period** – a predetermined period during which Free Spins are available to the Player for obtaining, activation, or use. The start and end of the Promotional Period are always specified in the terms of the specific Bonus Offer or in the description of the promotion on the Operator’s website.

**Bonus Offer** – a specific marketing-promotional offer of the Operator under which Free Spins are provided to the Player under predetermined conditions. The Bonus Offer specifies in particular the method of obtaining Free Spins, their number, the value of one spin, validity, terms of use, any game restrictions, and wagering requirements, if applicable.

**Verified Account** – a player account for which the Operator has successfully performed identification and verification of the Player’s identity in accordance with the Gambling Act, AML/KYC regulations, and the Operator’s internal procedures. Free Spins and winnings from them may be credited and paid out only to a Verified Player Account.

**Minimum Bet Amount** – the lowest financial value of a game round or a set of game rounds that the Player must achieve on designated games within the Bonus Offer in order to meet the conditions for obtaining, activating, or releasing winnings from Free Spins. The exact Minimum Bet Amount is always stated in the terms of the respective Bonus Offer.

## **D) Obtaining the Bonus**

### **1. For registration**

- The Player may receive Free Spins automatically after successful registration and account verification.

### **2. For deposit or wagering activity**

- Free Spins may be granted after reaching a certain level of activity (e.g., making a deposit, wagering a minimum amount).

### **3. Tournaments and promotions**

- Free Spins may be awarded as a reward for participation in tournaments or other promotional activities organized by the Casino.

### **4. Granting limit**

- Free Spins are granted only once per promotional event per player account.

## **E) Activation and Crediting of the Bonus**

### **1. Free Spin conditions**

- The Player receives Free Spins after fulfilling the conditions stated in the Bonus Offer on the Organizer’s website (for example wager amount, number of losses, etc.), as well as any additional conditions defined by the promotion on the Organizer’s website.
- Only games listed in the Bonus Offer are counted toward the wager amount. Table games (Roulette, Blackjack) are not included.

## **2. Activation of Free Spins**

- Free Spins are credited to the player account in the “Bonuses” section.
- The Player must accept the awarded bonus, if such confirmation is required.

## **3. Validity**

- Free Spins are valid only during the Promotional Period and have a defined validity period. The bonus is time-limited and takes place in the Gameworldbet online casino. The start and end of the Bonus are specified on the provider’s website in the “Bonuses” section.
- After expiry of the validity period, any unused Free Spins expire without compensation.

## **F) Use of Free Spins**

### **1. Designated games**

- Free Spins may be used only on designated slot games or groups of games defined by the Organizer in the promotional offer.

### **2. Spin value**

- Each Free Spin has a fixed and unchangeable value determined by the Organizer.

### **3. Activation in the game**

- After launching the selected game, Free Spins are automatically activated and the specified number is deducted.

### **4. Bonus progress**

- During gameplay, the Player is shown the current progress of the bonus or the number of Free Spins used.

### **5. Use of the bonus**

- The Player may play and use only one bonus at a time. If the Player activates another bonus during the use of an active bonus in violation of the promotion’s terms, the original bonus — including any winnings from it — may be canceled.
- Cashback or Tournament promotions are not considered concurrent bonuses unless otherwise stated in their terms.
- Changes to the terms do not apply to bonuses that have already been granted or activated before the effective date of the change.

## **G) Winnings from Free Spins**

### **1. Winnings and crediting**

- Winnings obtained from Free Spins are credited to the player account in accordance with the promotion terms stated on the Organizer's website, no later than within 48 hours.

### **2. Wagering requirements**

- If stated in the promotion, winnings from Free Spins may be subject to wagering requirements.
- The specific wagering amount is always stated for the relevant promotion on the Organizer's website.

### **3. Withdrawal of winnings**

- Withdrawals of winnings are possible only after all conditions have been met, including the Casino's gambling and bonus rules.

## **H) Breach of Conditions and Sanctions**

A breach of the Statute is considered in particular:

- creating or using multiple accounts
- coordinated or group play
- using bots, scripts, technical or automated tools
- manipulating results or bets
- any other conduct contrary to the purpose of the promotion or good morals

## **I) Final Provisions**

Gameworldbet is not responsible for temporary unavailability of services caused by technical outages of an objective nature. Gameworldbet reserves the right to change the rules or terms of the promotion at any time, including changing its duration or terminating the promotion without compensation, effective from the date of publication on <https://www.gameworldbet.sk/>.

If the Organizer has a justified suspicion of fraudulent, dishonest, or unfair conduct by a participant or another person, or if such conduct occurs, the participant will be excluded from the promotion

without compensation; the same applies in the event of any conduct by a participant or another person that is contrary to these rules, conditions, or legal regulations.

In case of doubt regarding the interpretation of these rules, the Organizer's interpretation shall always prevail, and the final decision on disputed matters rests with the Organizer. Participation in the promotion cannot be enforced through legal proceedings. Otherwise, the course of the promotion and the relationships between the participant and the Organizer are governed by the legal system of the Slovak Republic as the applicable law.

The rules are always available on the website <https://gameworldbet.sk/>. In the event of a discrepancy between the shortened rules stated in any promotional material and these rules, the wording of these rules shall prevail.
