

# **STATUTE OF THE PROMOTIONAL ACTIVITY – CASINO TOURNAMENT**

Valid for all tournaments in the Gameworldbet online casino.

## **A) Introductory Provisions**

1. This statute (hereinafter the “Statute”) regulates the conditions of participation, course, evaluation, and payment of winnings in the Operator’s marketing-promotional activity of the Casino Tournament type (hereinafter the “Tournament”).
2. The Tournament is intended for registered players of the Operator’s online casino and takes place during the Tournament Period specified in its description.
3. By participating in the Tournament, the Player confirms that they have become acquainted with this Statute, agree with its wording, and undertake to fully comply with it.
4. The organizer of this activity is GameWorld s. r. o., Korzo Bélu Bartóka 2387/24, 929 01 Dunajská Streda, Company ID: 46 465 472 (hereinafter also the “Organizer”).

## **B) Conditions of Participation in the Tournament**

1. A Player may participate in the Tournament if he/she:
  - is over 18 years of age and meets the conditions laid down by Act No. 30/2019 Coll. on Gambling
  - has an active and verified player account
  - does not violate the General Terms and Conditions, the Game Plan, or this Statute
  - meets any qualification requirements specified in the Tournament description
2. Participation in the Tournament may be:
  - automatic (the Player is included by playing Tournament Games), or
  - subject to activation of the Tournament, whereas the method of participation is stated in the terms of the specific Tournament

3. Only games played:

- during the Tournament Period
- on Tournament Games
- with real-money stakes, unless expressly stated otherwise

are included in the Tournament.

### **C) Tournament Rules and Definitions**

**Weighted Number of Spins** is a scoring criterion under which the Player earns points for each individual game round (spin) played on Tournament Games during the Tournament Period that meets the minimum bet requirement set for the given Tournament. Each game round in which the minimum bet amount has been reached or exceeded is counted as one point, unless otherwise stated in the Tournament terms. The Minimum Number of Rounds represents the lowest number of game rounds a Player must complete to be included in the Tournament Leaderboard.

**Total Bet Amount** is a scoring criterion where the ranking of Players is determined based on the total financial value of bets placed on Tournament Games during the Tournament Period. Points are awarded according to a predetermined ratio between the value of bets and the number of points (e.g., 1 point for every X EUR wagered), and only game rounds meeting the minimum bet requirement are counted. The Minimum Number of Rounds determines the minimum number of game rounds required for inclusion in the Leaderboard.

**Total Weighted Wins** is a scoring criterion where the ranking of Players is determined based on the sum of ratios of individual wins to corresponding bets (win / bet) achieved during the Tournament Period. For each winning game round that meets the minimum bet requirement, the weighted win is calculated as the ratio of the amount of the win to the amount of the bet. These values are then summed and form the Player's total score in the Tournament. The Minimum Number of Rounds is a condition for inclusion in the Leaderboard.

**Highest Weighted Win** is a scoring criterion where the ranking of Players is determined by the highest single ratio of win to bet (win / bet) achieved during the Tournament Period. Only game rounds played on Tournament Games that meet the minimum bet requirement are included. If multiple winning rounds occur, only the Player's highest weighted win is taken into account. The Minimum Number of Rounds determines eligibility for inclusion in the Leaderboard.

**Total Wins** is a scoring criterion where the ranking of Players is determined based on the total sum of all winnings achieved on Tournament Games during the Tournament Period. Only winnings from game rounds that meet the minimum bet requirement are included. In the event of a tie (equal total wins), ranking is determined according to the time the result was achieved, unless the Tournament terms specify another tie-breaking criterion.

#### **D) Scoring and Course of the Tournament**

1. The Player earns points according to the scoring rules stated in the Tournament terms.
2. The Operator is entitled to:
  - correct scoring in case of a technical error or incorrect calculation
  - exclude results from games affected by technical malfunction or system outage
  - temporarily suspend or interrupt the Tournament in justified cases
3. Points earned in the Tournament cannot be transferred to another person or used in another tournament.

#### **E) Leaderboard and Determination of Ranking**

1. The ranking of Players is determined according to the number of points in the Leaderboard.
2. In the event of a tie, the following applies:
  - earlier time of achieving the result, or
  - an auxiliary criterion specified in the Tournament terms
3. After the Tournament ends, the Operator may verify the results; the final ranking becomes valid at the moment it is confirmed by the Operator.

## **F) Prizes and Their Crediting**

1. The type, number, and value of prizes (hereinafter the “Prizes”) are stated in the terms of the specific Tournament.
2. Prizes may take the form of:
  - cash winnings
  - bonus funds
  - free spins or another bonus reward
3. Bonus Prizes may be subject to wagering requirements or other restrictions; such conditions are published in advance.
4. The Operator is entitled to withhold or cancel a Prize if the Player has violated this Statute or obtained an advantage in contradiction with the Tournament rules.
5. Gameplay counted toward the Tournament may not simultaneously be counted toward other promotions, unless expressly stated otherwise.

## **G) Breach of Conditions and Sanctions**

1. A breach of the Statute is considered in particular:
  - creating or using multiple accounts
  - coordinated or group play
  - use of bots, scripts, technical or automated tools
  - manipulation of results or bets
  - other conduct contrary to the purpose of the Tournament or good morals
2. In case of justified suspicion, the Operator is entitled to:
  - exclude the Player from the Tournament
  - refuse to award or revoke a Prize
  - block or restrict the player account
  - take further steps in accordance with legal regulations

## **H) Responsible Gaming and Legal Relations**

1. The Player acknowledges the availability of self-limitation measures and responsible gaming tools.
2. For matters not regulated by this Statute, the following shall apply accordingly:
  - the General Terms and Conditions
  - the Game Plan
  - applicable legal regulations of the Slovak Republic

## **I) Amendment, Suspension, and Termination of the Tournament**

1. The Operator is entitled to unilaterally modify, suspend, or terminate the Tournament at any time, even during its duration, if required by technical, operational, or legislative reasons.
2. The Operator is not liable for temporary unavailability of services caused by technical outages of an objective nature.
3. Changes to the Tournament conditions do not apply to Tournament Periods that began before the effective date of the change, unless such change is required by technical or legislative necessity.

## **J) Final Provisions**

Gameworldbet reserves the right to change the rules or terms of the promotion at any time, including changing its duration or terminating it without compensation, effective from the date of publication on <https://www.gameworldbet.sk/>.

If the Organizer has a justified suspicion of fraudulent, dishonest, or unfair conduct by a participant or another person, or if such conduct occurs, the participant will be excluded from the promotion without compensation; the same applies in the event of other conduct contrary to these rules, conditions, or legal regulations.

In case of doubt regarding the interpretation of these rules, the Organizer's interpretation shall prevail and the final decision on disputed matters rests with the Organizer. Participation in the

promotion cannot be enforced through legal proceedings. Otherwise, the course of the promotion and the relationships between the participant and the Organizer are governed by the legal order of the Slovak Republic as the applicable law.
